**EMERGENCY POWERS (COVID 19 PANDEMIC)
REGULATIONS, 2020**

**EMERGENCY POWERS (COVID 19 PANDEMIC)(STORM
PREPAREDNESS)(AMENDMENT) ORDER, 2020**

In exercise of the power conferred on me by the Emergency Powers (Covid 19 Pandemic) Regulations, 2020, I HEREBY make the following Order —

1. Citation.

This Order may be cited as the Emergency Powers (Covid 19 Pandemic)(Storm Preparedness)(Amendment) Order, 2020.

2. Revocation and replacement of order 2 of the principal Order.

Order 2 of the principal Order is revoked and replaced as follows —

“2. Application.

This Order shall apply to all islands except Mayaguana, Inagua, Chub Cay, Long Cay, Long Island, Rum Cay, Ragged Island and Spanish Wells.”.

3. Amendment of order 3 of the principal Order.

Order 3 of the principal Order is amended —

- (a) in paragraph (1), by the insertion immediately after the word “daily” of the word “curfew”;
- (b) by the deletion and substitution of subparagraph (2)(r) as follows —
 - “(r) essential workers, including contractors or subcontractors, in any public or privately owned utility provider of water, electricity or electronic communications;”.

4. Amendment of order 9 of the principal Order.

Order 9 of the principal Order is amended in paragraph (1), by the insertion immediately after subparagraph (i) of the following new paragraphs —

- “(ia) Financial services, shall be permitted to operate for the purposes of a transaction that cannot be carried out remotely and limited to only Senior Officer 1 and Senior Officer 2, together with not more than

ten employees, Monday through Friday between the hours of 9:00 am and 3:00 pm;

- (ib) money transmission services shall be permitted to operate Mondays through Friday between the hours of 9:00 am and 5:00 pm;”.

5. Insertion of new order 15A into the principal Order.

The principal Order is amended by the insertion, immediately after order 15 of the following new order 15A —

“15A.Exemptions.

The Competent Authority, may by letter, in exceptional circumstances and in consultation with public health professionals, exempt a business or class of business from any restriction imposed by this Order.”.

6. Amendment of order 19 of the principal Order.

Order 19 of the principal Order is amended by the deletion and substitution of paragraph (a) as follows —

- (a) this Order shall apply to every establishment or business permitted to operate pursuant to Emergency Powers (Covid 19 Pandemic)(No. 3) Order, 2020 except those establishments or businesses specifically permitted to open under this Order;”.
